Stand Your Ground laws upend centuries of traditional self-defense doctrine and threaten public safety by encouraging armed vigilantism, allowing a person to kill another person in a public area even when they can clearly and safely walk away from the danger

STAND YOUR GROUND (2)

- The "Stand Your Ground" provision of Chapter 776 Florida statute does not restrict the time frame for determining immunity, but rather provides a time continuum stretching across the entire criminal process, including the arrest, detention, charging, and prosecution
